

INVITATION TO BID FOR *Procurement of Goods for Supplemental Feeding*

1. The *Municipality of Guiguinto*, through the 2016 General Fund, intends to apply the sum of *Php 1,499,423.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Medicines for RHU of the Municipality of Guiguinto*. Bids received in excess of the ABC shall be automatically rejected at time of bid opening.
2. The *Municipality of Guiguinto*, now invites bids for the *Procurement of Medicines for RHU of the Municipality of Guiguinto*. Delivery of goods is required *within thirty (30) calendar days upon issuance of Notice to Proceed and Purchase of Order*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from *Municipality of Guiguinto* and inspect the Bidding Documents at the address given below during *8:00 am to 4:00pm*.

A complete set of Bidding Documents may be purchased by interested Bidders on *November 25, 2016 to December 13, 2016* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

Bids must be delivered to the address below on or before *December 14, 2016, 12:01 pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**
