Invitation to Bid for Concreting of New Road

1. The Municipality of Guiguinto, through the DILG-DBM Assistance to Disadvantaged Municipalities intends to apply the sum of Php 20,107,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting of New Road located at Mañalac St. to Municipal Compound, Poblacion, Guiguinto Bulacan/public bidding no. GTO-2017-17. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Municipality of Guiguinto, through the DILG-DBM Assistance to Disadvantaged Municipalities intends to apply the sum of Php 20,107,000.00 for Concreting of New Road located at Mañalac St. to Municipal Compound, Poblacion, Guiguinto Bulacan being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The Municipality of Guiguinto now invites bids for *Concreting of New Road*¹ Completion of the Works is required 120 working days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the Municipality of Guiguinto and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on *July 14, 2017 to August 02, 2017*, upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Php 25,000.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity,

provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Municipality of Guiguinto* will hold a Pre-Bid Conference² on *July 21, 2017* at *VIP Lounge of GMACC, Poblacion, Guiguinto, Bulacan*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *10:00 am, August 04, 2017*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on *2:00 pm, August 07, 2017* at *GMACC VIP Lounge*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Municipality of Guiguinto* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
