

INVITATION TO BID FOR *Procurement of Automatic Transfer Switch and Generator Set for Ospital ng Guiguinto*

1. The *Municipality of Guiguinto*, through the 2016 *ONG-General Fund*, intends to apply the sum of *Php 1,100,000.00* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Automatic Transfer Switch and Generator Set for Ospital ng Guiguinto*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Guiguinto*, now invites bids for the *Procurement of Automatic Transfer Switch and Generator Set for Ospital ng Guiguinto*. Delivery of items is required *within fifteen (15) calendar days upon issuance of Notice to Proceed and Purchase of Order*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from *Municipality of Guiguinto* and inspect the Bidding Documents at the address given below during *8:00 am to 5:00pm*.

A complete set of Bidding Documents may be purchased by interested Bidders on *July 20, 2016 to – August 9, 2016* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The *Municipality of Guiguinto* will hold a Pre-Bid Conference on *July 27, 2016, 2:00 pm* at *GMACC VIP Lounge, Poblacion, Guiguinto, Bulacan*, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before *August 9, 2016, 12:01 pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on *August 9, 2016, 2:00 pm* at *GMACC VIP Lounge Municipal Compound, Poblacion, Guiguinto Bulacan*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The *Municipality of Guiguinto* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
