 - A complete set of Bidding Documents may be purchased by interested Bidders on *July 20, 2016 to August 9, 2016* from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Php 5,000.00*.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
