Invitation to Bid for
CONSTRUCTION OF GUIGUINTO MUNICIPAL REFORMATION
CENTER/BAHAY PAGBABAGO – PHASE 2

1. The Municipality of Guiguinto Bids and Awards Committee, through the 20% Development Fund¹ intends to apply the sum of Php 11,732,217.35 being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF GUIGUINTO MUNICIPAL REFORMATION CENTER/BAHAY PAGBABAGO – PHASE 2 / GTO-2021-06. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Municipality of Guiguinto Bids and Awards Committee now invites bids for 2nd Floor Level.² Completion of the Works is required within 180 working days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipality of Guiguinto Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm

5. A complete set of Bidding Documents may be acquired by interested bidders on March 12, 2021 to March 30, 2021 from the BAC Secretariat, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 25, 000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Municipality of Guiguinto Bids and Awards Committee will hold a Pre-Bid Conference³ on March 19, 2021 at 1:00 pm at VIP Lounge, GMACC, Poblacion, Guiguinto, Bulacan which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before 10:00am March 30, 2021. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in

Bid opening shall be on March 30, 2021 at 1:00pm at VIP Lounge, GMACC, Poblacion, Guiguinto, Bulacan. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Municipality of Guiguinto Bids and Awards Committee reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
