

STRATEGIC LOCATION AND ACCESSIBILITY


The Municipality of Guiguinto is traversed by 4 major arterial roads namely, the Manila North Road (MNR) or McArthur Highway, North Luzon Expressway (NLEX), the Cagayan Valley Road or Daang Maharlika Road, and the Plaridel Bypass Road. These roads conveniently link this small town to other parts of Luzon and Metro Manila through various modes of transportation system.



The modes of transportation available in Guiguinto are buses, FX/Van/UV Express, jeepneys, tricycles, and pedicabs. There are different bus lines (Baliwag Transit, Inc., Victory Lines, Philippine Rabbit, etc.) that use the three major arterial roads in Guiguinto. Regular trips are available from these bus companies every day.








The business sector in Guiguinto maintains an upward trend in the number of business registrations and total gross receipts from the year 2013 to 2021

Guiguinto is recognized for its ornamental products and services. Most industries in the municipality are considered light industries or small-scale industries. Half of these are in the manufacturing business.



INCENTIVES OF NEW ESTABLISHMENTS WITH NATURE INCLUDED IN THE INVESTMENT PRIORITY AREAS BASED ON MUNICIPAL INVESTMENT INCENTIVE CODE SB ORDINANCE NO. 273, S. 2018

- Full exemption from payment of Mayor's Permits, business permit, locational clearance, sanitary, occupancy, and electrical permits for one (1) year
- Exemptions/Discounts on payment of Business Tax for one (1) year (full exemption, 10%, and 20% discount based on capitalization)

STEPS OF BUSINESS REGISTRATION

STEP 1: For checking of complete documentary requirements and sworn statements. One time assessment will be provided by BPLO head then clearance from bureau of fire (BFP) will follow after assessment.

STEP 2: Payment and releasing of official receipt, business permit certificate, plate and other regulatory certificate.










GUIGUINTO MAP
